*The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation*

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business shall be:

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

**TO FURTHER AND PROVIDE EDUCATIONAL ASPECTS OF LIFE IN SANIBEL AND ENVIRONS, WITH THE INTENTION TO PROMOTE THE STUDY OF, APPRECIATION OF, AND INTEREST IN THE FINE ARTS AND IN ALLIED AND RELATED CREATIVE ARTS AND CRAFTS. ART EXHIBITIONS ARE TO BE HELD FROM TIME TO TIME OR CONTINUOUSLY AS THE DIRECTORS MAY SEE FIT. SUCH EXHIBITIONS ARE TO BE OPEN TO THE PUBLIC: TO ACQUIRE WORKS OF ART, TO RECEIVE, INVEST OR DISBURSE FUNDS AND TO HOLD PROPERTY BOTH REAL AND PERSONAL FOR THE PURPOSE OF THE CORPORATION. IN THE EVENT OF THE DISSOLUTION OF THE CORPORATION, ANY ASSETS REMAINING IN THE HANDS OF THE DIRECTORS SHALL BE PAID OVER TO SUCH EDUCATIONAL OR CHARITABLE CORPORATIONS OR ASSOCIATIONS IN SANIBEL, LEE COUNTY AS THE DIRECTORS SHALL DECIDE AND NOT OTHERWISE. ACCORDING TO THE INFORMATION FURNISHED, WE SPONSOR MONTHLY EDUCATIONAL MEETINGS, AND WEEKLY SKETCH CLASSES FOR THE MEMBERS AND THE PUBLIC. THE MEMBERS OF THE GENERAL PUBLIC**

**ARE INVITED TO ATTEND OUR MONTHLY MEETINGS. A MEMBER OF OUR MEMBERSHIP COMMITTEE IS PRESENT AT THE MEETINGS AND CLASSES TO RECEIVE APPLICATIONS FOR MEMBERSHIP.**

**WE ARRANGE ART EXHIBITS EACH YEAR BY THE BROADER MEMBERSHIP FOR A SMALL ENTRY FEE. SINCE WE DO NOT OWN A BUILDING, MEETINGS ARE HELD WHERE CONVENIENTLY FOUND. MOST OF OUR ART WORKS ARE AVAILABLE FOR SALE WITH THE PROCEEDS GOING TO THE ARTISTS. OUR FINANCIAL STATEMENT SHOWS RECEIPTS IN DUES AND DONATIONS; EXPENSES: ROOM RENTAL, PRINTING, POSTAGE, ART COUNCIL DUES, PROGRAM DEMONSTRATORS AND REFRESHMENTS.**

#### **ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

**THE PRESIDENT APPOINTS A NOMINATION COMMITTEE. THE NOMINATION COMMITTEE SELECTS CANDIDATES FROM THE GENERAL MEMBERSHIP AND WITH THE CANDIDATES PERMISSION THE SLATE IS PRESENTED TO THE MEMBERSHIP FOR THEIR APPROVAL.**
