Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation filed January 19, 2000:

FIRST: Amendment adopted:

ARTICLE 4

On all matters upon which the membership shall be entitled to vote, there shall be one vote for each Condominium Parcel that consists of 35% or more of the total square footage of the Condominium. The votes shall be cast in the manner provided in the By-Laws of the Association.

ARTICLE 7

- 7.3 The first election of the members of the board of directors by the members of the Association shall be held within thirty days of the completion of the sale of all condominium parcels. DILO, LC will provide notice of the election within seven days of the completion of the sale of all condominium parcels.
- 7.4 At the first election of the members of the board of directors the voting shall be cumulative. By this, is meant that each member shall have one vote for each available board member position. Since there are four board member positions, each member shall have four votes. Each member may use their vote on one or more of the board of director positions. It takes a minimum of two votes to elect a director.

ARTICLE 8

8.2 The first election of officers of the association shall occur immediately subsequent to the first election of the members of the board of directors.
