We undersigned, Rev. Miguel A. Velazquez, Rev. Roberto Zayas and Mrs. Vilma I. Garcia hereby make subscribe acknowledge and file Articles of Incorporation (A corporation for not-profit) with the Department of the State of Florida as follows:

ARTICLE I

The name of the corporation shall be: BE DELIGENT MINISTRIES, INC. (Ministerio "Avanza" Inc.) a corporation for not profit, with offices at: 2019-B East 149th Avenue, Lutz, Fl. 33549

ARTICLE II

PURPOSE

The general purpose of this corporation shall be:

- A. To organize missionary work for the teachings of the Gospel of Jesus Christ within the United States of America and foreign countries.
- B. To promote the teachings of the words and Gospel of Jesus Christ Among the members of the church as well as non-members
- C. To ordain Christians workers to visit hospitals and jails and other institutions.
