# ARTICLE OF INCORPORATION OF ONE ACCORD OUTREACH CHURCH INC.

The UNDERSIGNED, natural persons of legal age acting as incorporators of a not-for-profit corporation under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such applicable corporation.

# ARTICLE I- NAME

The name of this corporation is ONE ACCORD OUTREACH CHURCH INC. ARTICLE II- DURATION

The period of its duration is perpetual.

# ARTICLE III- NATURE OF BUSINESS
