

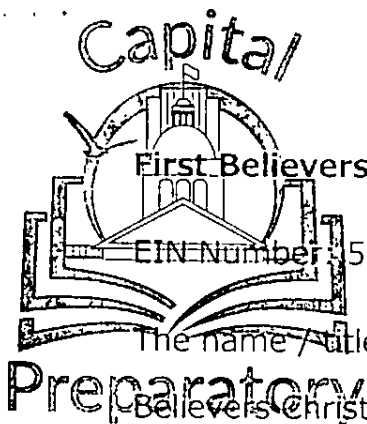

On February 9, 2017, First Believers Christian Center, Inc. submitted a request to be recognized as a d/b/a Capital Preparatory (*document #G02000002036*) on February 17, 2017 (*#G17000014954*) the request was voluntarily withdrawn.

Later, a LLC was opened and that application too was withdrawn to after the opening of another account. Up until the LLC, the Agent for First Believers opened each account. After careful consideration and review of the course of events, reopening of the d/b/a is warranted with full explanation based on the time frame...First Believers Christian Center, Inc., d/b/a Capital Preparatory.
