ARTICLES OF INCORPORATION
OF
THE ASHEVILLE CONDOMINIUM ASSOCIATION, INC.
A FLORIDA CORPORATION NOT FOR PROFIT

The undersigned incorporators by these articles associate themselves for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopt the following articles of incorporation:

ARTICLE I. NAME AND ADDRESS

The name of this corporation is THE ASHEVILLE CONDOMINIUM ASSOCIATION, INC. and the street address of its initial principal office and its mailing address is 3046 VIRGINIA STREET, COCONUT GROVE, FL 33133. For convenience, the corporation shall be referred to in this instrument as the "association," these articles of incorporation as the "articles," and the bylaws of the association as the "bylaws."

ARTICLE II. TERM OF EXISTENCE

The association shall have perpetual existence.

ARTICLE III. PURPOSE

This association is organized for the purpose of providing an entity under the Florida Condominium Act ("the Act") for the operation of a condominium located in Miami-Dade County, Florida, and known as THE ASHEVILLE, A CONDOMINIUM ("the condominium"), to be created under the declaration of condominium ("the declaration").

ARTICLE IV. MEMBERS

The qualification of members and the manner of their admission shall be as regulated by the bylaws.

ARTICLE V. INITIAL REGISTERED OFFICE
AND REGISTERED AGENT

The street address of the initial registered office of this corporation is 95 MERRICK WAY, SUITE 440, CORAL GABLES, FL 33134 and the name of the initial registered agent of this corporation at that address is LUIS F. DE LA CRUZ, JR.

ARTICLE VII. ELECTION OF DIRECTORS

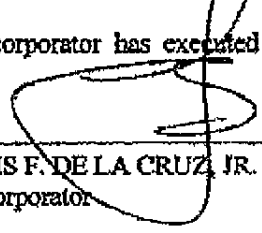
Successor directors shall be elected as provided for in the By-Laws.
