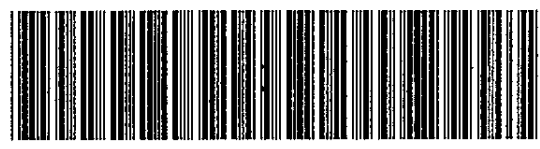

SECOND: Document Number unknown


THIRD: Adoption of Dissolution
