ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
COLLIERLEE, A HEALING FARM COMMUNITY, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: ARTICLE I of the Corporation's Articles of Incorporation is hereby deleted and the following is substituted in its place and stead:

ARTICLE I

The name of the corporation is **COLLIERLEE FARM, A HEALING COMMUNITY, INC.** (the "Corporation").

SECOND: The date of the adoption of the amendment was April 26th, 2002.
