ARTICLES OF INCORPORATION  
A NOT FOR PROFIT CORPORATION

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for THE COMMUNITY LEARNING CENTER OF DAYTONA, INC.

ARTICLE I  
NAME

The name of this corporation is: THE COMMUNITY LEARNING CENTER OF DAYTONA, INC. , the mailing address will be % Belinda A. McElveen

ARTICLE II  
DURATION

4636 South Moon Trail  
Port Orange, Florida 32129

The period of the duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon the date filed with the Department of State.

ARTICLE III  
PURPOSE(S)

The purpose for which the corporation is organized are for Charitable, Educational, Literacy, and Scientific purposes including for such purposes as making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954, (or corresponding provision of any future United States Internal Revenue Law).

The purpose of this organization shall be to enhance the lives of the citizens of the City of Daytona Beach, Volusia County, the State of Florida and wherever there are people in need of social services. The organization shall establish and maintain schools and colleges for men and women, and children.

The organization shall establish, maintain and conduct community-based self-help programs such as schools, after-school tutorial programs, seminars, workshops, vocational education and mentoring for both young and old.

This organization shall establish, maintain and otherwise operate orphanages, homes for the aged, rescue missions, day-care centers and any and all other facilities necessary to aid the general public, in accordance to the discipline, rules, regulations, rituals, rites, ceremonies and practices which are now being or from time to time hereafter may be followed, prescribed, designated, formulated, promulgated and established by the officers of this organization.

This organization shall have, hold and possess real and personal property either by purchase, lease or gift, to be used and employed for the purposes and objectives of this corporate body, to mortgage, sell property and to contract for the erection of buildings and for all other matters deemed advisable, to promote and extend the functions and activities of this organization, or all those things which may be deemed advisable at any time and from time to time hereafter by the officers of this organization.

This organization is organized exclusively for charitable, religious, educational and scientific purposes, and for such other purposes as shall be allowed by law.

#### ARTICLE IV

The membership of this corporation shall constitute all persons hereafter named as members of said corporation, and such others as from time to time hereafter, may become members in a manner provided in the By Laws. A two-thirds vote of member present in any regular or special meeting called for in the manner provided in the By-laws.

#### ARTICLE V

The number constituting the Initial Board of Directors of the corporation is six (6) and the names and addressees of the persons who are to serve initially. Trustees are elected according to the By Laws.

## ARTICLE VI

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local Code. Notwithstanding any other provision of these Articles this corporation shall not carry on any other activities not permitted to be carried on by (a) corporation exempt from Federal Income tax under section 501(c)(3) of the Internal Revenue Code of 1954, the corresponding provision of any future United States Internal Revenue law (b) a corporation's contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 or other corresponding provision of any future United States Internal Revenue Law.

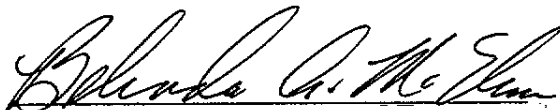

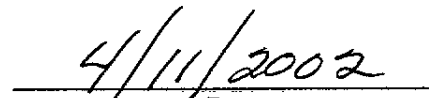
