ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the corporation shall be Cape Kennedy Corvette Club, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
1046 Fairlawn Drive
Rockledge, FL 32955-3032

ARTICLE III PURPOSE

- 3.1 The general purposes of Cape Kennedy Corvette Club, Inc., shall be to encourage planned trips, events and social activities for members of the Club. Members will regulate events and exhibitions for Corvette owners and enthusiasts and encourage careful and skillful driving on public roads.
- 3.2 The Club will also maintain liaison with similar organizations to promote rallies and other vehicle competitions, bring together persons with a common interest of working on Corvettes.
- 3.3 The club shall gather material, which will be of use to the majority of the members, and increase understanding of the Corvette by members and non-members.

ARTICLE IV MANNER OF ELECTION

- 4.1 Prior to all elections, the President shall appoint a nominating committee headed by the Officer-at-Large, at least one-month preceding the elections. This committee shall take nominations from the floor of at least one member of the Club for each of the Board of Directors positions, except for the position of Immediate Past President. Nominations made from the floor require only a second to be added to the ballot. This must be completed before the election of each officer is in progress.
- 4.2 The Board of Directors shall be elected at the November meeting.
- 4.3 The term of the Board of Directors will be the calendar year.
- 4.4 In event that any Officer other than the President shall resign or become unable to fulfill the duties of the elected office, the Board of Directors shall have the power to designate a member to temporarily fill the vacated office. Upon convening of the next scheduled general membership meeting or as soon as possible thereafter a general election will be held with nominations from the floor. The temporary designee at this time will automatically be placed on the election ballot unless stated otherwise by said person.
