

### AMENDMENT TO ARTICLES OF INCORPORATION FOR DOLPHIN POINTE, A CONDOMINIUM

WHEREAS, in compliance with the requirements of Chapter 617, Florida Statutes, Waterside V at Bay Beach Condominium Association, Inc. ("Association"), a Florida not-for-profit corporation, filed its Articles of Incorporation with the Florida Secretary of State on April 15, 2002;

WHEREAS, the Association wishes to amend its Articles of Incorporation in accordance with the terms and conditions set forth below and pursuant to Article VIII therein.

NOW, THEREFORE, the Articles of Incorporation are hereby amended as follows [all deleted text is overstricken and all added text is bold and underlined]:

1. Article I is amended to read as follows:

ARTICLE I. NAME & ADDRESS. The name of the corporation, herein referred to as the "Association" is Waterside V <u>Dolphin Pointe at Waterside</u> Condominium Association, Inc., and its address is 7401 Estero Blvd., Ft. Myers Beach, Florida 33931 4137 Bay Beach Lane, Ft. Myers Beach, Florida 33931.

2. Article II is amended to read as follows:

ARTICLE II. DEFINITIONS. The definitions as set forth in Section <u>7</u> of the Declaration of Condominium shall apply to the terms used in these Articles.

3. Article III is amended to read as follows:

ARTICLE III. PURPOSE AND POWERS. The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act for the operation of Waterside V-Dolphin Pointe, a Condominium, located in Lee County, Florida. The Association is organized and shall exist upon a non-stock basis as a Florida corporation, not for profit. No portion of any earnings of the Association shall be distributed to or inure to the private benefit of any member, Director or officer. For the accomplishment of its purposes, the Association shall have all the common law and statutory powers and duties of a corporation, not for profit, except as expressly limited or modified by these Articles, the Declaration of Condominium or by Chapter 718 Florida Statutes, as it may hereafter be amended, including but not limited to the following:

[The remaining provisions of Article III shall remain the same.]

4. Article XI is amended to read as follows:

ARTICLE XI. INDEMNIFICATION. To the fullest extent permitted by Florida law, the Association must shall indemnify and hold harmless every Director and every officer of the Association against all expenses and liabilities, including attorney's fees, actually and reasonably incurred by or imposed on him personally in connection with any legal proceeding (or settlement or appeal of such proceeding) to which he may be a party because of his being or having been a Director or officer of the Association. The foregoing right of indemnification shall not be available and the Director or officer shall be liable for monetary damages as provided in Section 617.0834, Florida Statutes as amended, if a judgment or other final adjudication established that his actions or omissions to act were material to the cause adjudicated and involved such Director of officer breached or failed to perform his duties as an officer or Director; and the breach of, or failure to perform his duties constitutes:

- (A) Willful-misconduct or a conscious disregard for the best interests of the Association, in a proceeding by or in the right of the Association to procure a judgment in its favor.
- (B) A violation of criminal law, unless the Director or officer had no reasonable cause to believe his action was unlawful or had reasonable cause to believe his action was lawful.
- (C) A transaction from which the Director or officer derived an improper personal benefit.
- (D) Recklessness, or an act or omission which was committed I bad faith or with malicious purpose or in manner exhibiting wanton and willful disregard for hum rights, safety or property, in an action by or in the right of someone other than the Association or a member.
- (E) Wrongful conduct by Directors or officers appointed by the Developer, in a proceeding brought by or on behalf of the Association.

In the event of a settlement, the right to indemnification shall not apply unless the Board of Directors approves such settlement as being in the best interest o the Association. The foregoing rights of indemnification shall be in addition to and not exclusive of all other rights to which a Director or officer may be entitled.

5. Article XII is added to read:

#### ARTICLE XII. MISCELLANEOUS.

- (A) Number and Gender. The use of the singular includes the plural and the use of the male includes the female and neuter and vice versa in this document.
- (B) Severability. Should any portion hereof be void or become unenforceable, the remaining provisions of these Articles shall remain in full force and effect.
- 6. All other terms and conditions of the Articles of Incorporation not amended hereby shall remain in full force and effect.
