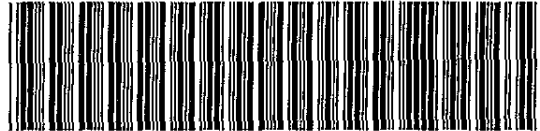

Articles of Amendment

Article I. Name and Principle Office, is amended to read:

The name of the corporation is Spyglass Homeowners Association, Inc., a Non-Profit Corporation, and shall have its mailing address as Post Office Box 2319, New Smyrna Beach, FL 32169.

Article III. Purpose, is amended to read:

The only purposes for which this corporation are organized is:

1. To maintain and operate the river access common area located between lot 7 and lot 6 and north of lot 6 of the Spyglass Subdivision as shown in Plat Book 42, Page 103, and Official Records Book 3225, Page 0481, Public Records of Volusia County, Florida, tax parcel ID No. 7405-03-00-0001.
2. To maintain operate the common water retention areas.
3. To do other such things that are incidental to the foregoing or necessary to accomplish the foregoing.
