**ARTICLES OF INCORPORATION
OF
Miami Beach Debate Boosters, Inc.
a not-for-profit corporation**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation not-for-profit for the purpose of conducting their business and promoting the purposes hereinafter stated, under the provisions of Chapter 617 of the Florida Statutes, and for these purposes to adopt the following Articles of Incorporation:

**ARTICLE I
NAME AND ADDRESS**

The name and address of this Corporation are **Miami Beach Debate Boosters, Inc.** and **Attn: Bruce Reich**, 1111 Lincoln Road, Suite 802, Miami Beach, FL 33139.

**ARTICLE II
PURPOSES**

- A. This not-for-profit corporation is organized for the following purposes:
 - (i) To provide support for the Miami Beach Senior Highschool Debate Team.
 - (ii) To promote debating programs for Miami Beach youth.
- B. This Corporation is organized and shall be operated exclusively for purposes for which a not-for-profit corporation may be formed under the laws of the State of Florida, the purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") and the Regulations promulgated thereunder (the "Regulations"), and not for pecuniary profit or financial gain.
- C. This Corporation shall have the power, either directly or indirectly, either alone or in conjunction or cooperation with others, to do any and all lawful activities which may be necessary, useful, suitable, desirable, or proper for the furtherance, accomplishment, fostering, or attainment of any or all of the purposes for which this Corporation is organized, and to aid or assist other organizations whose activities are such as to further, accomplish, foster, or attain any of such purposes.
- D. Notwithstanding anything herein to the contrary, this Corporation may exercise any and all, but no other, powers as are in furtherance of the exempt purposes of organization set forth in Section 501(c)(3) of the Code and its Regulations as the same now exist, or as they may be hereafter amended from time to time.

**ARTICLE VII

Amendments to these Articles of Incorporation may be proposed by any member of the Board of Directors and must be adopted by a simple majority vote of the Directors present at any regular meeting of the Board of Directors or at any special meeting called for such purpose.

**ARTICLE IX
REGISTERED AGENT**

- C. The initial Registered Office shall be 767 Arthur Godfrey Road, Miami Beach, FL 33140.

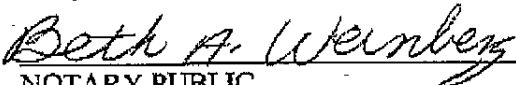

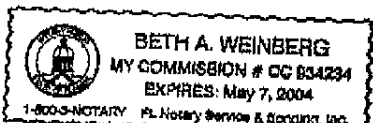

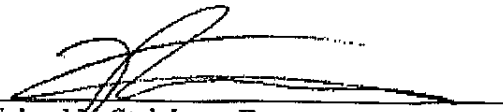
