(CGHI), received the UBR, made the necessary changes, and sent the report along with her personal check to the Division of Corporations. I was elected president of CGHI in March 2002, and when the UBR didn't arrive in April, I contacted the Division of Corporations and found out that they had returned the UBR to Ms. Coburn last year because it wasn't filled out completely.
