ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

The Sculptural Art Center of Dunedin, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

ARTICLE IV MANNER OF ELECTION

A director may be removed from office, with or without cause, by an affirmative vote of a majority of the directors present at a duly called meeting.

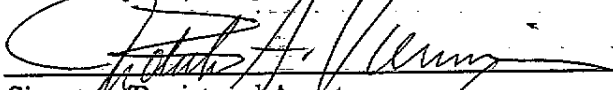

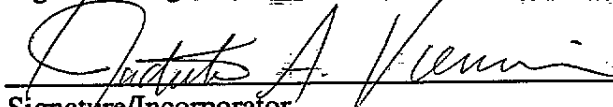
