ARTICLES OF INCORPORATION
OF
COMPREHENSIVE COMMUNITY CARE NETWORK, INC.

THE UNDERSIGNED SUBSCRIBER, for the purposes of forming a corporation, not for profit under Chapter 617 of the Florida Statutes, hereby subscribes to, acknowledges and files the following Articles of Incorporation:

ARTICLE I- NAME AND ADDRESS

The name of this corporation is Comprehensive Community Care Network, Inc.. The principal office and mailing address of the corporation shall be 2330 South Congress Avenue, West Palm Beach, Florida 33406. Such address may be revised from time to time by the Board of Directors.

ARTICLE II- EFFECTIVE DATE AND DURATION

The duration of this corporation is perpetual commencing on the date these Articles are filed with the Florida Department of State, unless sooner dissolved according to law.

ARTICLE III- PURPOSES

The corporation shall be organized exclusively for charitable, religious, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. To that end, the principal objectives and purposes for which this corporation is organized are as follows:

A. To establish a not for profit corporation for the purpose of providing medical, housing, counseling, information, education and support services to persons in need of health care and their families, health care professionals and the general public.

B. To provide administrative, financial and other ancillary support services to other not for profit corporations.

C. To do everything necessary, proper or convenient for the accomplishment of the purposes set forth herein, and to do every other act which is not forbidden under the laws of the United States of America or the State of Florida (particularly, Chapter 617, Florida Statutes).

D. To qualify as an organization exemption from federal income taxation under Section

501(c)(3) of the Internal Revenue Code of 1986, as amended, and to such end the corporation will not carry on any activities not permitted to carried on by a corporation exempt from federal income taxation under said Section 501(c)(3), and these Articles shall be construed consistently with the requirements thereof.

Provided, however, that no part of the net earnings or assets of the corporation shall inure to the benefit of, or be distributed to its directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes hereinabove set forth. Provided, further, that no substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

ARTICLE IV- AMENDMENT

These Articles of Incorporation may be amended, altered, changed or repealed by the affirmative vote of a majority of the individuals serving on the Board of Directors, at any regular meeting or special meeting called for that purpose.

ARTICLE V- INITIAL OFFICE AND AGENT

The street address of this corporation's initial registered office in Florida is 2330 South Congress Avenue, West Palm Beach, Florida 33406, and the name of its initial registered agent at that address is Larry Leed.

ARTICLE VI- DIRECTORS

The number of directors shall be stated in the bylaws, but shall never be less than three (3). The method of election of directors shall be stated in the bylaws.

ARTICLE VII- INCORPORATOR

ARTICLE VIII- BYLAWS

The Bylaws of the corporation shall be initially adopted by the Board of Directors, and may be changed or repealed by the affirmative vote of a majority of the Board of Directors at any meeting thereof.

ARTICLE IX- DISSOLUTION

In the event of dissolution, the residual assets of the corporation will be turned over to one or more organizations organized and operated exclusively for charitable, educational, religious or scientific purposes which themselves are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
