**ARTICLES OF INCORPORATION**

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation and do hereby certify:

**ARTICLE I**

*Name* \_

The name of the corporation shall be:

INTERNATIONAL CHRISTIAN UNIVERSITY, INC.

**ARTICLE II**

*Principal Place of Business and Mailing Address*

The principal place of business and the mailing address of this corporation shall be:

310 S. Dillard St., Ste. 310  
Winter Garden, FL 34787

The Board of Directors may from time to time move the principal office to any other address in Florida, and so notify the Secretary of State.

**ARTICLE III**

*Purpose(s)*

The purpose(s) for which the corporation is organized is (are):

INTERNATIONAL CHRISTIAN UNIVERSITY, INC. is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under

Section 501c (3) of the Internal Revenue Code, or the corresponding sections(s) of any future federal tax code.

It is the purpose of this educational institutions to offer and admit students of any race, color, national and ethnic origin to all the rights, privileges, programs and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.

The specific purposes of INTERNATIONAL CHRISTIAN UNIVERSITY, INC. are:

1. To offer biblical and instructional courses from a biblical perspective via correspondence, for religious vocations only.
2. There shall be three levels of study: Bachelors, Masters and Doctorate.
3. Upon completion of the necessary credit hours, life experience credits, transfer of credits, or an accumulation of all as set forth by the Florida Statutes and the Commission of Education, the students shall be given the corresponding degree which qualifies for the course of study.
4. The initial Bachelor Degrees shall be:
  - a. Bachelor in Theology
  - b. Bachelor in Ministry
  - c. Bachelor in Christian Counseling
  - d. Bachelor in Elementary Christian Education
5. The initial Master Degrees shall be:
  - a. Master in Theology
  - b. Master in Ministry
  - c. Master in Christian Counseling
6. The initial Doctorate Degrees shall be:
  - a. Doctorate in Theology
  - b. Doctorate in Ministry
  - c. Doctorate in Christian Counseling
7. To sell and distribute text books and other course materials to enrolled students.
8. Those contracted as Faculty shall grade papers, tests, quizzes and counsel students on their intended area of discipline.

9. The Administrative Offices shall receive inquires from potential students, respond by letter, email, phone or by sending a catalogue if requested. They will also maintain students records such as grades, transcripts, letters of recommendations, and student and the school's accounting records.
10. All students' activities sponsored by INTERNATIONAL CHRISTIAN UNIVERSITY, INC. will be overseen either by a Faculty member or a member of the Board of Directors and must be in accordance with intended purpose of this institution as specified in paragraphs 1, 2 and 3 of this Article.
11. To work with various ministries both domestic and abroad.
12. To utilize various forms of media to advertise: ex: magazines, newspapers, television, radio.
13. To offer the students to accompany various ministries on missionary trips.
14. To offer scholarships to those who qualify- meeting the required criteria of the scholarship. All scholarships will be offered on a racially nondiscriminatory basis.
15. To sponsor charitable events to benefit the local community either annually or bi annually.

Contributions and grants aid will be received to fund this endeavor and to pay reasonable expenses; However, in no event, no part of the organization's net earnings will inure to the benefit of private shareholders, the Founder and/or President and his family, Board of Directors and their families, or any other private interests.

#### ARTICLE IV

##### *Manner of Election of Directors*

The affairs of INTERNATIONAL CHRISTIAN UNIVERSITY, INC. shall be conducted by the Board of Directors, which shall consist, initially of twelve(12). The number of directors may be varied from time to time as provided in the By-Laws; however, in no case may the number be less than three (3) as provided for in the Florida Statutes. Directors shall be appointed according to the provisions set forth in the By-laws.

The Directors themselves must possess the qualifications of leaders as set forth in the relevant teachings of the New Testament and they shall have the duties as set forth therein. Directors, once in office, shall serve so long as they remain members of the organization/ministry unless sooner removed as set forth herein.

---

The Directors shall appoint such other persons as may be necessary to properly carryout the purposes for which the school is organized. Persons so appointed shall be subject to the provision of Section 741.07, Florida Statutes, and to any rules or By-Laws which may be adopted by the Directors of the organization/school. Once appointed they shall serve so long as they remain members of the organization/school, unless sooner removed as set forth herein.

The Board of directors will make an effort to act with unanimity. However, all actions of the Board shall be with the concurrence of at least 2/3<sup>rd</sup>s of the Directors, unless stated otherwise.

If any decisions which cannot be successfully resolved at a meeting of the Board of Directors, the matter will be considered and a final decision made by the President.

## ARTICLE V

### Limitation of Corporate Powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: NONE

Additional powers of the corporation:

1. To counsel and direct students towards a religious vocation they believe they are "called" to do.
2. To write and/or purchase courses which meet the academic standards as set forth by of the Commissioner of Education for the State of Florida.
3. To qualify for grants available for non-profit projects.
4. To hold graduation ceremonies annually for those students who have completed their course of study.

No part of the activities of the corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

No part of the organization's or school's earnings or assets may inure to the benefit of any director, officer or member, except as reasonable compensation for services actually rendered.

## ARTICLE VI

### Dissolution

If it is necessary or desirable to dissolve the corporation, the provisions of s.617.1402, s.617.1403, and s.617.1406 shall govern. The corporation may be dissolved by a unanimous vote of the full Board of Directors. In the event of such dissolution, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation or to such organization(s) organized and operated exclusively for charitable, religious, educational, or scientific purposes as shall at the time qualify as an exempt organization(s) under Section 501(c)(3) of the Internal Revenue Code or Law. The Board of Directors shall determine to whom distribution to whom distribution will be

made, but in any case no distribution may be made to any organization not qualified under Section 501c(3).

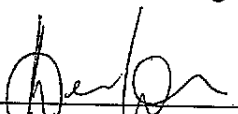

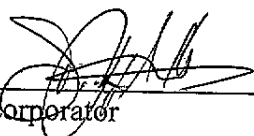
