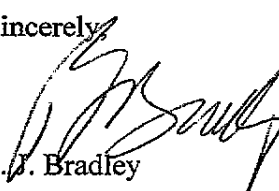

ARTICLES OF INCORPORATION
OF

The undersigned incorporators, for the purpose of forming a non-profit corporation under the Florida Statute, Chapter 617, hereby adopt the following Articles of Incorporation.

ARTICLE 1
NAME

The name of the corporation shall be KOREAN PRESBYTERIAN CHURCH OF WEST PALM BEACH, INC.

ARTICLE 2
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business is 13689 Okeechobee Boulevard, Loxahatchee, Florida 33470, and the mailing address is P. O. Box 221041, West Palm Beach, FL 33422.

ARTICLE 3
PURPOSES

INITIAL REGISTERED AGENT AND REGISTERED OFFICE

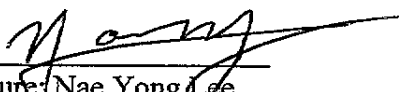

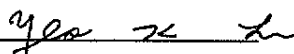

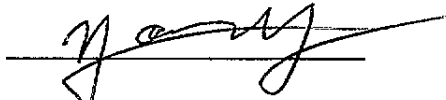
