

ARTICLES OF INCORPORATION
OF
BETHLEHEM MISSIONARY BAPTIST CHURCH
OF TITUSVILLE, FLORIDA, INC.

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, do hereby form a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of this Corporation is:

BETHLEHEM MISSIONARY BAPTIST CHURCH OF TITUSVILLE, FLORIDA, INC.

ARTICLE II: PURPOSE

To promote a spirit of brotherly and sisterly love, friendship, and benevolence; to assist the pastor of the congregation and to advance the good and welfare of the congregation by the use of the talents and abilities of the members of the Corporation; to voluntarily render financial or other assistance to members of the congregation in need, in the spirit of Christian charity; to contribute, financially and otherwise, toward the work of the congregation's agencies of mercy and benevolence; to engage in work projects for the benefit of the congregation and its members; and, in general, to promote, in word and deed, the spiritual and material welfare of the congregation and its members.

ARTICLE III

The amount of capital with which this corporation will begin business is \$500.00.

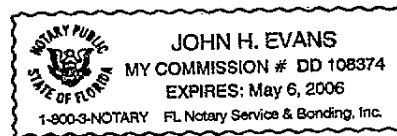
