ARTICLE I: NAME

The name of the corporation shall be Joseph Daniel Ministries International, Inc.

ARTICLE II: STATEMENT OF CORPORATE NATURE

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, (Not for Profit) adopts the following Articles of Incorporation of such corporation.

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is to rebuild individuals, families, communities and nations. Focusing on the spiritual, social and economic aspects, and to bear through the prophetic voice renewed lives and fulfillment of destiny. Joseph Daniel Ministries International, Inc. believes that we have the responsibility before our Lord, to prepare and position nations for a visitation from God. It is our prayer that God would increase our vision for the things that attract His presence. We are committed to cultivating and reproducing people with a vision for the nations and a mission to transform lives by the Word, intercession/prayer and an uncompromising desire to see the Glory of God revealed.

The organization is a charitable religious organization operated exclusively for the purpose of advancing religious teachings. The earnings of the organization are solely for the advancement of religion. None of the earnings of the organization shall insure to the benefit of any private member or individual. The organization may not engage, other than as an incidental part of its activities, in activities that are not in furtherance of one or more of these purposes.

ARTICLE IV: MANNER OF ELECTION

The qualifications for members and the manner of their admission will be provided for in the bylaws. Directors shall also be elected in the same manner.

Principal address is same as registered office address.





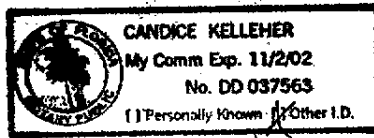
