

## PLAN OF DISTRIBUTION

Plan of Distribution of the West Coast Civic Ballet, Inc., a nonprofit corporation organized and existing under the laws of the State of Florida (the "Corporation").

1. Approval of Plan.

This plan shall become effective on approval by a majority of the Board of Directors of the Corporation, in compliance with Fla. Stat. §617.1406.

2. Distribution of Assets.

a. The personal property set forth in Exhibit "A," attached hereto (hereinafter the Charitable Assets), are held by the Corporation for charitable, eleemosynary, benevolent, or an educational purpose and not upon a condition requiring return, transfer, or conveyance by reason of the dissolution of the corporation. The Charitable Assets are currently being held by Deborah Vinton, the former Artistic Director of the Corporation, at 1370 Boulevard of the Arts, Sarasota, Florida. Ms. Vinton has refused to return the Charitable Assets to the Corporation for distribution.

b. All other assets held by the Corporation upon a condition requiring return, transfer, or conveyance by reason of the dissolution of the corporation, shall be returned, transferred, or conveyed in accordance with the requirements appertaining to them.


c. The Corporation shall pay any and all liabilities and obligations, if any from the remaining assets of the Corporation.

d. If any assets remain after payment of its liabilities and obligations, the Corporation shall make one or more pro rata distributions to members, in cash or in kind, of those assets, if any, to the extent that they are legally available for distribution in accordance with the provisions of the corporation's Articles of Incorporation, Revised By-Laws and applicable law.

e. As soon as practicable, the corporation shall dissolve and file Articles of Dissolution in compliance with the provisions of Fla. Stat. §617.1403.

This Plan of Distribution was approved by a vote of the directors, pursuant to the Articles of Incorporation and By-laws of the Corporation on the 17<sup>th</sup> day of April, 2014.
