**ARTICLES OF INCORPORATION
OF
DISABLED PATRIOTS OF AMERICA, INCORPORATED**

The undersigned incorporator, for the purpose of forming a corporation under Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be: DISABLED PATRIOTS OF AMERICA, INCORPORATED.

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 8806 Northwest 38th Drive, #1, Coral Springs, Florida 33065.

**ARTICLE III
PURPOSE**

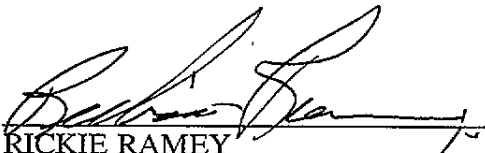

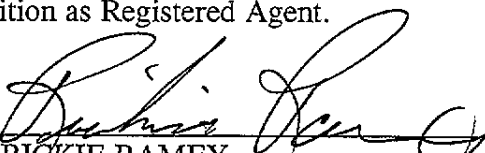
