ARTICLE I - NAME

The name of this organization is GFWC Ridge Women's Club, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business, and mailing address, of this corporation is 936 Via Bianca Drive, Davenport FL 33896.

ARTICLE III - PURPOSE

No part of the net income or earnings of the corporation shall inure to the benefit of any individual member or be distributed to its members or officers.

ARTICLE IV - MANNER OF ELECTIONS

The officers shall be elected by ballot to serve for a term of one year, or until their successors are elected. The term of office shall begin at the close of the annual meeting in May. If there is only one nominee for an office, the election may be by voice vote.
