- I. CORPORATE NAME – The name of the Corporation is:

- II. PRINCIPAL OFFICE – The 3T Mentors, Inc. shall have its principal office at

- III. PURPOSE – The purpose for which 3T Mentors, Inc. is organized are exclusively

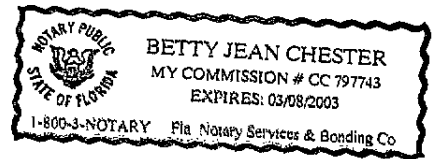
