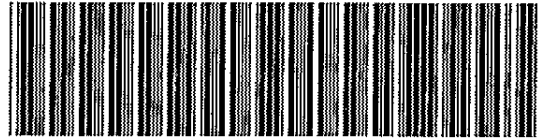

ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be:

TREASURE COAST AQUATICS & DIVING, INC.

ARTICLE II

The principal place of business and the mailing address of this corporation shall be: 1909 S.W. WINNERS DRIVE, PALM CITY, FLORIDA, 34990.

ARTICLE III

The street address of the initial registered office of this corporation is:
1909 S.W. WINNERS DRIVE, PALM CITY,
FLORIDA, 34990.

The name of the initial registered agent of this corporation at that address is: Darla Toner

ARTICLE IV

This corporation shall have (3) directors initially. The number of directors may be either increased or diminished from time to time but shall never be less than (3). The qualifications of members of the Board of Directors and the manner of their election will be prescribed by the By-Laws of the corporation. The names and addresses of the initial Directors of this corporation are:

ARTICLE V

The purpose for which the corporation is formed, and the business and the objectives to be carried on and promoted by it, are as follows:

1. The corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501c(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The corporation may receive, and administer, and maintain funds or real or personal property exclusively for charitable, religious, scientific, literary, or educational purposes, within the meaning of 501c(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended, and to that end the corporation is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value, to dispose of any such property and to invest, reinvest, or deal with the principal or income in such manner as, in the judgment of the directors, will best promote the purposes of the corporation, without limitation, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of the Corporation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for pecuniary profit or financial gain of its directors, members, or officers.
2. The specific purpose for which the corporation is organized shall be: TRAINING IN THE SWIMMING AND DIVING SPORT.
3. To erect and maintain a building or buildings for the above purpose and to engage in any operation incidental to and essential to carry out the purposes above mentioned.
4. To solicit funds and donations in kind and from time to time to further the purpose of this corporation.

5. To acquire and receive by purchase, donation or otherwise, any property, real, personal, or mixed, and to hold, use and dispose of the same.
6. To borrow money and to issue evidences of indebtedness in furtherance of any or all of the objects of its business; and to secure loans by mortgage, pledge, deed of trust, or other lien.
7. To apply for, obtain, and contract with any federal, state or local government or agency for a direct loan or loans or other financial aid in the form of grants or otherwise relating to the purposes of this corporation.
8. To engage in any kind of activity, and to enter into, perform and carry out contracts of any kind, necessary or in connection with, or incidental to the accomplishment of any one or more of the non-profit purposes of the corporation.



ARTICLE VII

1. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any Director or Officer of the corporation or any member of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no Member, Director or Officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

2. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501c(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170c(2) of the Internal Revenue Code and said Regulations as they now exist or as they may hereafter be amended.
3. In the event of the Corporation's dissolution, and after paying or making provisions for the payment of all liabilities of the corporation, the corporation's residual assets will be distributed exclusively to one or more charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Sections 501c(3) and 170c(2) of the Internal Revenue Code of 1986, or Successor Sections, or distributed to the Federal, State, or local government exclusively for public purposes. Any such assets not so disposed of shall be disposed of by the appropriate Court of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
