ARTICLES OF INCORPORATION
OF
NATIONAL HISPANIC SOCIETY
USPS SOUTH FLORIDA CHAPTER, INC.

In Compliance with Chapter 617, F.S., (Not for Profit), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not for profit corporation.

ARTICLE I

The name of the corporation ("Corporation") is NATIONAL HISPANIC SOCIETY USPS SOUTH FLORIDA CHAPTER, INC.

ARTICLE II

The street address of the principal office of the Corporation is 9661 SW 123rd Street, Miami, Florida 33176.

ARTICLE III

The Corporation is organized and operated exclusively for charitable purposes and other charitable endeavors within the meaning of Section 501 of the Internal Revenue Code of 1986, as amended. The purpose for which the corporation is formed are (1) to foster greater understanding and appreciation of Hispanic culture, (ii) to participate in cultural diversity awareness activities, (iii) to provide mentors and role models to the youth and community, (iv) to inform the Hispanic community of employment opportunities in the postal service, (v) to foster goodwill and encourage training and self-fulfillment and (vi) to encourage positive and creative communication among the Hispanic communities. The corporation, in furtherance of its corporate purposes set forth, shall have all the powers enumerated in F.S. Chapter 617, Corporations Not-for-Profit, subject to any limitations provided herein or in any other statute of the State of Florida. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, (or the corresponding provision of any future United States Internal Revenue Law), or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services tendered to or for the

corporation), and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by IRC §501(h)] or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.

In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC §501(c)(3), or corresponding another provisions of any subsequent Federal tax laws, or to the Federal government, or state or local government for a public purpose.

ARTICLE IV

The initial Board of Trustees shall consist of the individuals named in Article V. The Board shall be elected or appointed as described in the by-laws.
