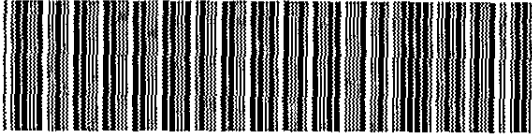

**ARTICLES OF INCORPORATION
OF
Ebano y Marfil, Inc.
A Florida "Not for Profit" Corporation**

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

Article I
NAME OF CORPORATION

The name of the corporation is Ebano y Marfil, Inc.

Article II
PRINCIPAL OFFICE & MAILING ADDRESS

The principal office of the corporation is located at 8010 Crespi Blvd. Apt # 3 Miami Beach, FL 33141

The mailing address of the corporation is the same as above.

Article III
PURPOSE OF THE ORGANIZATION

The purposes for which this corporation is formed are exclusively charitable and educational and consist of the following:

1. To promote community wide interest and concern for the problems of the black Cuban community and other ethnic groups to eliminate racial prejudice and discrimination, economic and otherwise.
3. To raise the economic, educational and social levels of the black Cuban community and other ethnic groups, who are substantially unemployed, underemployed, or whose income is below federal poverty guidelines
4. To expand the opportunities available to said minorities to own, manage, and operate business enterprises and to assist them in developing the entrepreneurial and management skills necessary for the successful operation of business enterprises, and to help them in obtaining the necessary financial support.
5. The purposes of this organization will be implemented as much in the United States as in a future democratic Cuba.

All of the foregoing purposes shall be exercised exclusively charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article IV
MEMBERSHIP/DIRECTORS

The corporation shall have a voting membership as defined in the corporation bylaws. The qualification for members, if any, and the manner of their admission shall be regulated by the bylaws. The management and affairs of the corporation shall be all the times under direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's bylaws. Also, the method of election of directors shall be stated in the bylaws. No member or director shall have any right, title or interest in any property of the corporation.
