ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

HAITIAN EDUCATIONAL DEVELOPMENTAL ORGANIZATION, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized is:

To provide the Haitian community with education designed to assist them understand the social, political and economic aspects of the United States in an effort to help them better adapt to life in the United States.

This corporation is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision or any future United States Internal Revenue Law) or (h) by a corporation contributions to which are deductible under section 170 (b)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law). Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and or scientific purposes and which has established its tax exempt status under section 501 (c) (3) of the Internal Revenue Code.

ARTICLE IV MANER OF ELECTION OF DIRECTORS

The manner in which directors are elected or appointed is:

The business affairs of the corporation shall be managed by a board of Directors. The number shall be initially four (4) directors and may be increased from time to time by the By-Laws but shall not be less than three (3). Directors shall be appointed as provided in the By-Laws.
