

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

ARTICLE II - NATURE OF BUSINESS

Such actions as may be necessary shall be deemed to have been taken by the appropriate officers to accomplish this compliance.

ARTICLE VI - TERM OF EXISTENCE

ARTICLE VII - LIMITATION OF LIABILITY

The foregoing right of indemnification shall be inclusive of any other rights to which any director or officer may be entitled as a matter of law.


