

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be:

West Pasco Girls Fast Pitch Softball Association, Inc.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any lawful business activities permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation. Purpose to provide recreational softball for girls ranging in age from 6 to 18 years of age.

ARTICLE III - CAPITAL STOCK

There shall be no issuance of capital stock for this corporation.

ARTICLE V - SPECIAL PROVISIONS

This corporation is intended to operate exclusively as a non-profit educational organization providing supervised program of competitive youth softball league activities qualifying under the requirements of Section 501(c)(3) of the Internal Revenue Code and the regulations issued thereunder. Such actions as may be necessary shall be deemed to have been taken by the appropriate officers to accomplish this compliance.

ARTICLE VI - TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE VII - LIMITATION OF LIABILITY

Each director and officer, in consideration for his services, shall, in the absence of fraud, be indemnified, whether then in office or not, for the reasonable cost and expenses incurred by him in connection with the defense of, or for advice concerning any claim asserted or proceeding brought against him by reason of his being or having been a director or officer of the corporation to the maximum extent permitted by law. The foregoing right of indemnification shall be inclusive of any other rights to which any director or officer may be entitled as a matter of law.

ARTICLE VIII - ELECTION OF DIRECTORS

Directors shall be appointed yearly per majority vote of the general membership.

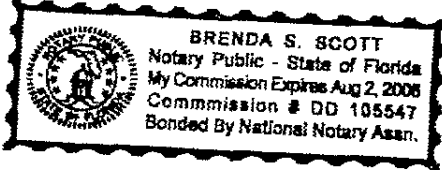




