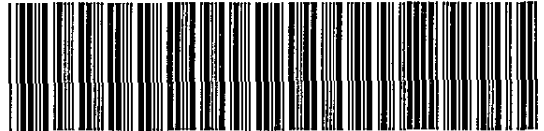

Articles of Incorporation of the undersigned, who is a citizen of the United States, desiring to form a Non-Profit corporation under the Non-Profit Laws of the State of Florida, does hereby certify:

First: The name of the Corporation shall be Planet Gumbo, Incorporated

Second: The place in this state where the principal office of the Corporation is to be located is 2873 Saint Augustine Road, Monticello, FL 32344 in Jefferson County.

Third: Said Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including (for such purposes) the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: The incorporator shall call for volunteers to serve on the board of directors within 90 days after the filing of articles of incorporation and shall call a meeting of such board to elect corporate officers. Directors shall serve for one-year terms, and the future Board of Directors shall elect subsequent directors by a majority vote.

Fifth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporations shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing of distribution of statements) any political campaign on behalf of in opposition to any political candidate for public office. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from the federal income tax under sections 501 (c) (3) of the Internal Revenue Code, or the corresponding section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: The initial Registered Agent shall be William Wharton, whose address is 2873 Saint Augustine Road, Monticello, FL 32344

Seventh: The Incorporator shall be William Wharton, whose address is 2873 Saint Augustine Road, Monticello, FL 32344

Eighth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) or the Internal Revenue Code, or the corresponding section of any future federal tax code, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated for such purposes.
