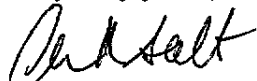

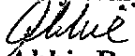

The undersigned subscriber to these Articles of Incorporation, with other persons being desirous of forming a non profit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of this corporation is:

ADIDAM OF MIAMI, INC.

ARTICLE II

The principal place of business and mailing address of the corporation is:

710 NE 126 Street, N. Miami FL 33161

The Board of Directors may from time to time move the principal office to any other address in the State of Florida and establish branches and subsidiaries in any place within and without the United States.

ARTICLE III

NATURE OF BUSINESS

The purposes for which this corporation is organized and the objects and purposes to be transacted and carried on are:

To further the general welfare and wellbeing of the religious community of Adidam, and to educate and enrich the congregation of Adidam, and in addition to conduct any and all lawful business for non profit corporations which may be incorporated under the laws of the State of Florida.

And in general, to carry on any other business whatsoever in connection with the foregoing or which is calculated directly or indirectly, to promote the interest of the corporation or to enhance and benefit its endeavors.

And further, to borrow or raise money for any purposes of the religious congregation, and to secure the same interest, or for other purposes, to sell, convey or mortgage all or any part of the property corporeal or incorporeal, if any, including rights of franchises of this company now owned or hereinafter acquired, and to create, issue, draw and accept and negotiate bonds and mortgages, bills of exchange, promissory notes or other obligations or negotiable instruments.

ARTICLE IV

This Directors of the corporation shall be selected by members of the congregation. The initial number of directors shall be none. The number of Board of Directors may be increased from time to time in accordance with by-laws adopted by the congregation, but shall never be less than three.

ARTICLE V

The Effective Date of this Corporation shall be March 11, 2002.

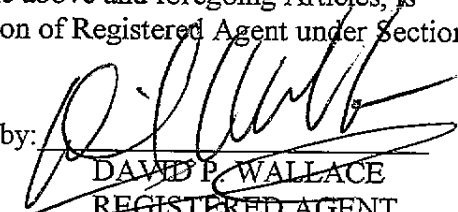

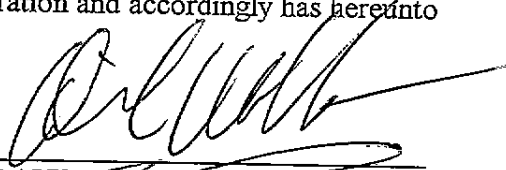
