#### **ARTICLE I**

#### **NAME**

The name of the corporation shall be MAROMA PLAYERS, INC.

#### ARTICLE II

The principal place of business and the mailing address of this corporation shall be: 380 N.W. 59<sup>Ct</sup> Miami, FL 33126

#### ARTICLE III

The purpose of this Corporation shall be to educate and inform the community of Florida, and the United States, as to the value of international Hispanic theatre and other Hispanic art. This primary purpose will be carried out by producing theatre, musical theatre, with an emphasis on new work, holding theatre and music workshops for playwrights, for the purpose of creating new works, having educational program for children, adults and professionals. All productions will offer students and professional multi-cultural actors in the community the opportunity to create and perform in works produced by Maroma Players, Inc.

The purposes for which the corporation is organized are exclusively charitable within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

#### ARTICLE IV

#### MANNER OF ELECTION OF DIRECTORS

At the initial meeting of the Board of Directors, following Incorporation, the full Board of Directors of Maroma Players, Inc., will be elected, as stated in the Corporation Bylaws.

#### ARTICLE V

#### LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, and with no limitations defined herein.
