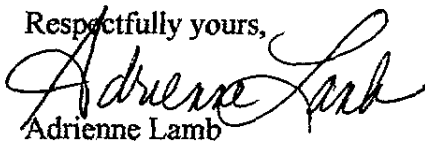

### ***Articles of Incorporation***

In compliance with Chapter 617, F.S. (Not for Profit)

**Articles of Incorporation** of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Chapter 617.0202, F.S., do hereby certify:

#### **Article I**

The name of the Corporation shall be ***Helping Offenders Progress Through Education and Employment, Inc.***

#### **Article II**

The place in this state where the principal office of the Corporation is to be located at ***3826 NW 202 Street, Miami, Florida 33055*** in the county of Miami-Dade.

#### **Article III**

Said corporation is organized exclusively to provide educational services and resources to youth and adult offenders that promote self-sufficiency and aid in ex-offenders becoming productive, law-abiding members of society, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **Article IV**

The names and addresses of the initial ***appointed*** trustees/officers of the corporation are as follows:

The Board of Directors shall be ***appointed*** by the President.

## **Article V**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members trustees, officers, or other private persons except that the corporation shall be authorized and empowered to pay compensation for or to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in the Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## **Article VI**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
