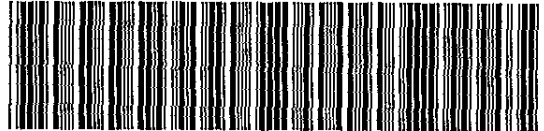

**ARTICLES OF INCORPORATION  
OF

The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I - Name:** The name of the Corporation shall be: Friends of Journey's End, Inc.

**Article II:** The principal place of business and mailing address of this corporation shall be: 193 Cedar Avenue, Orange City, Florida 32763

**Article III:** Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of the corporation is to: raise money in order to educate and raise public awareness to the avoidance of cruelty to animals and to the financial support of Journey's End Animal Sanctuary, Inc., in Glenwood, Florida.

**Article IV:** The manner in which directors are appointed is: by appointment by the Incorporator at the first organizational meeting.

**Article V:** The corporation shall have eleven (11) directors. The initial directors' names and addresses are:

**Article VI:** No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the

corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.

**Article VII:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.


**Article VIII:** The registered agent and registered office of this corporation are:


