ARTICLES OF INCORPORATION OF OLD BRIDGE HOMEOWNERS' ASSOCIATION, INC

The undersigned, being not less than two-thirds of all of the mobile home owners of Old Bridge Village, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Articles of Incorporation:

ARTICLE I.

The name of the corporation is "OLD BRIDGE HOMEOWNERS' ASSOCIATION, INC."

ARTICLE II. NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefits of its Members, Directors or Officers, except to the extent permissible under law.

ARTICLE III. PURPOSES

The Corporation is organized and shall be operated exclusively as a non-stock organization for the following purposes:

- To establish an association of homeowners of mobile homes located at Old Bridge Village in Lee County, Florida;
- In order to exercise the rights provided in Florida Statutes 723.071 including, but not limited to, exercising its right to negotiate for, acquire and operate the mobile home park of Old Bridge Village on behalf of the mobile home owners;
- In order to exercise its right to convert the mobile home park to a condominium, a cooperative form of ownership, or other type of ownership pursuant to Florida law;
- To exercise and engage in any other powers or business of mobile home park associations as permitted by Florida law:
- To engage in any lawful activities which are in furtherance of the purposes of the Corporation as described herein; and
- To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including, without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein, and to do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE IV. DURATION AND TIME AND DATE OF COMMENCEMENT

The duration of the Corporation is perpetual, and the Corporation shall commence at the time and date of filing of these Articles with the Secretary of State.

ARTICLE V. LIMITATION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, trustees or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III (Purposes) hereof.

ARTICLE VI. MEMBERS

Each Home-Owner within the Park having consented, in writing to become members and their successors shall become members of the association and shall be bound by the provisions of the articles of incorporation, the bylaws of the association and such restrictions as my be properly promulgated pursuant thereto. Each Home-Owner shall have appurtenant to it a membership in the corporation, which membership shall be held by the person or entity, or in common by the persons or entities owning such unit, except that no person or entity holding title to a unit as security for performance of an obligation shall acquire the membership appurtenant to the unit by virtue of the title ownership. In no event may any membership be severed from the unit to which it is appurtenant.

Each membership in the corporation shall entitle the holder or holders of it to exercise one vote per home. If there are more that one entity listed on the title the entities must submit a written authorization to the association indicating who shall be entitled to cast any votes. The names of the initial members are as listed on Exhibit "A".

ARTICLE VII. POWERS OF THE CORPORATION

To promote the health, safety, and welfare of the residents of the Home-Owners of Old Bridge Village, the corporation may:

- (1) Exercise all of the powers and perform all of the duties of the association as set forth in the in the bylaws, as those documents may from time to time be amended.
- (2) Determine, levy, collect, and enforce payment by any lawful means of all assessments for common charges, and pay such common charges as the same become due.

- (3) Engage the services of a professional corporate management agent and delegate to the agent any of the powers or duties granted to the association of the Home-Owners under the bylaws other than the power to engage or discharge the agent; the power to adopt, amend and repeal the provisions of it, bylaws, or rules and regulations of the Home-Owners.
- (4) Take and hold by lease, gift, purchase, devise or bequest any property, real or personal, including any Home, borrow money and mortgage any property to finance the acquisition of it on the vote of fifty percent of members, and transfer, lease, and convey any such property.
- (5) Have and exercise any and all rights, privileges and powers which may be held or exercised by corporations not for profit generally under Chapter 723 of the Florida Statutes.

ARTICLE VIII. INITIAL REGISTERED OFFICE AND AGENT

The street address of the Initial Principal and Registered Office of the Corporation is 1714 Cape Coral Parkway East, Cape Coral, Florida 33904, and the name of its initial Registered Agent is Robert B. Burandt.

ARTICLE IX. INITIAL BOARD OF DIRECTORS

The management of the Corporation shall be vested in a Board of Directors. The number of Directors constituting the initial Board of Directors is five (5). The number of Directors may be increased or decreased from time to time in accordance with the bylaws, but shall never be less than three (3). The Members of the Corporation shall elect the Directors as provided in the bylaws. The initial Directors are:

ARTICLE XII. BYLAWS

Bylaws regulating operation of the corporation are the Articles of Incorporation. The bylaws may be amended by the first board of directors until the first annual meeting of members. Thereafter, the bylaws shall be amended by the members in the manner set forth in the bylaws. The Bylaws shall conform with provisions of Florida Statutes 723.078, and other applicable laws.

ARTICLE XIII. AMENDMENT

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and all rights and privileges conferred upon the Members, Directors and Officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Florida, as amended from time to time, unless more specific provisions for amendments are adopted by the Corporation pursuant to law.

ARTICLE XIV. INDEMNIFICATION

The Corporation shall indemnify each Officer and Director, including the former Officers and Directors, to the fullest extent permitted by the laws of the State of Florida.

ARTICLE XV. NONSTOCK BASIS

This Corporation is organized on a nonstock basis. This Corporation shall not issue shares of stock.


