ARTICLES OF INCORPORATION OF

COMMUNITY OUTREACH FOR CHRIST CHURCH MINISTRIES INC

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: COMMUNITY OUTREACH FOR CHRIST CHURCH MINISTRIES INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business address of this corporation shall be: 9879 US 41 S. 117, Gibsonton, Florida 33534

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: Winning People To Iesus Christ, Building People Trough Training, Teaching And Preaching The Word Of God. Teaching, feeding, clothing And Sheltering The Homeless And Less Fortunate Bring Them The Love Of Christ.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
