Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: The following Articles have been revised as follows:

> Article 5. POWERS. [The following paragraph is inserted as 5.5 under Article 5, and the pre-existing 6.5, "Limitation", now becomes 5.6.]
