Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: The following Articles are being revised as follows:

Article 3. PURPOSE.

The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act as it exists on the date hereof (the "Act") for the operation of that certain condominium located in Miami-DadeBroward County, Florida, and known as **VUE, A CONDOMINIUM** (the "Condominium").

Article 4. DEFINITIONS.

The terms used in these Articles shall have the same definitions and meanings as those set forth in the Declaration of the Condominium to be recorded in the Public Records of Miami-DadeBroward County, Florida, unless herein provided to the contrary, or unless the context otherwise requires.

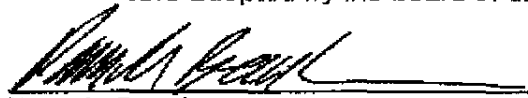
Article 13. AMENDMENTS.

13.5 Recording. A copy of each amendment shall be filed with the Secretary of State pursuant to the provisions of applicable Florida law, and a copy certified by the Secretary of State shall be recorded in the public records of Miami-DadeBroward County, Florida with an identification on the first page thereof of the book and page of said public records where the Declaration was recorded which contains, as an exhibit, the initial recording of these Articles.

SECOND: Date: The date of adoption of the amendments was November 24, 2003.
