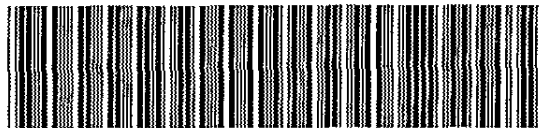

I. "God's House of Prayer, *INC.*

II. 1384 Malabar Road, *Palm Bay Florida 32909*

III. This corporation shall have perpetual duration.

IV. The business and prudential affairs of the Corporation shall be managed by it's Board of Directors; to act in, manage, and conduct all it's affairs and for that purpose for it's name, place and stead, and for it's use and benefit, to buy, receive, lease, accept or otherwise acquire, to sell, convey, mortgage, hypothecate, pledge, quit claim any property whatsoever and wheresoever situated be it real, personnel, or mixed now owed by the church or hereafter acquired, to make, do and transact all and every kind of business of what nature of kind whatsoever.

V. The officers of the Corporation shall be president, Vice-president and secretary. Such other officers as may be deemed necessary may be appointed by Board of Directors. All candidates selected for office must be baptized according to Acts 2:38, and filled with the Holy Ghost according to Acts 2:4; be of good moral character and in good standing in the "God's House of Prayer, Inc. Also, they must be faithful in attendance and committed to the ministry. After seeking the Lord, the CEO will bring before the board the name(s) of those selective to be a part of the board.

VI. The "God's House of Prayer, Inc. is presently reaching out to souls that are unsaved as well as those that need spiritual enrichment. We are having bible studies to enhance the spiritual growth and holy living in this area. We plan to visit those that are in prisons, orphan homes, as well as shelter, and whatever way we can help we will, with the help of Jesus. We are looking towards having revivals and many other activities to help reach out to a lost and dying world.

VII. The organization is organized exclusively for for charitable, religious, educational, and/or scientific purposes under section 501(c) (3) of the Internal Revenue Code.

b. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

c. Upon the dissolution of the organization, assets shall be distributed for one or more exempt

purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, for a public purpose.
