## Article III. Purpose.

The purpose of which the corporation is organized:

The objectives and purposes for which this Church is constituted and this corporation organized are:

- 1. To proclaim the gospel of Jesus Christ, that the people of God may be conformed to the image of Jesus Christ.

To develop and carry out programs of social action for poor, widowed, orphaned, afflicted, imprisoned, underprivileged or aged persons, both within and without this Church.
- 6. To support and encourage communication and extension of the Christian life and witness by sound and comprehensive preaching and teaching of the Gospel of the Lord Jesus Christ to all men, both within this fellowship and elsewhere.
