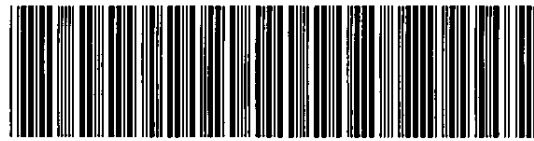

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

This corporation is to encourage, promote and perpetuate the teachings of our Lord and Savior, Jesus Christ. To own and establish churches, schools, missions and other properties deemed necessary to achieve our purpose. To be a place of healing, prayer, hope, and deliverance. To be a pure and undefiled religious, charitable and faith based not for Profit Corporation. Our mission is clearly stated in, Titus 2:11-15.

A. To minister in God's grace that has been given:

For the Grace (*presence, favor, and power*) of God, has appeared unto all men in the person of Jesus Christ. This grace brings with it salvation, a force or heavenly strength given to those who call upon the name of the Lord. This grace also instructs the believer to decisively reject the ungodly passions, pleasures, and values of this present world system and to regard them as an abomination to God. God requires the Christian to live soberly, righteously and godly, in this present world. Believers are to be different from the world; our lives are to reflect the life of Christ. The Word of God is what teaches us how to produce the character required to demonstrate to others our relationship with God. Our opinions (*a belief not based on absolute certainty or positive knowledge but on what seems true, valid, or probable to one's own mind*), are no longer valid, but are replaced with Gods truth and thoughts. The Bible (*the inspired, the infallible and the authoritative Word of God*) becomes the direction or instruction manual that enables the believer to live for God. Because the Word of God is inherent (*existing*

in someone or something as a natural and inseparable quality or characteristic or inborn), the life of Jesus Christ is made manifest in the life of the believer. This Bible or 'manual for daily living', will answer all questions concerning the decisions we make, guide our thoughts, and purify our motives.

B. To teach the Christian to live godly in this world:

All ungodliness, unbelief, worldly lust, disobedience; all corrupt and vicious desires, along with ungodly affections should be put away from us. We are to be examples of stability, regardless of the situation or circumstances. When we live soberly in respect to ourselves, our conduct reflects the Godly values that we have gleaned from spending time in and with the Word, (*our Lord and savior Jesus Christ*). We are to live in moderation in all things, which shows control or restraint provided to the believer by the indwelling of the Holy Spirit. The Christian must keep the limits of temperance, and righteousness, towards all men, rendering to all what is due to them. The blessed hope for the Christian is the glorious appearing of our Great God and Saviour Jesus Christ. This hope is never to be surrendered, realizing that this very well could be the day that our Lord returns. The unannounced return of Jesus requires that we live everyday as if it were our last day on earth and the end of this age, as we know it.

C. To teach the Christian to live a life of integrity:

There is a word that permeates the life of the believer, (*integrity; the quality or state of being of sound moral principle; uprightness, honesty, and sincerity*). This is actualized through trusting in the redemptive plan of God. Jesus' sacrifice and atonement for our sins has removed the curse from us, cleansed us from all unrighteousness and filthiness of the flesh making us fit for the Master's use. We are the children of God by faith in Jesus Christ. Through this process, we are His handy work, and have become instruments of salvation unto all men. This produces good works, (*moral or righteous deeds or acts*).

D. To reap the harvest of end time souls by equipping the saints to do the work of the ministry.

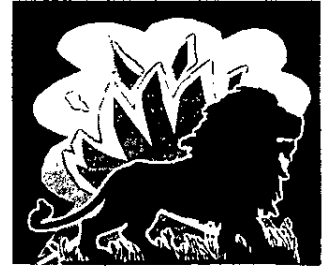
