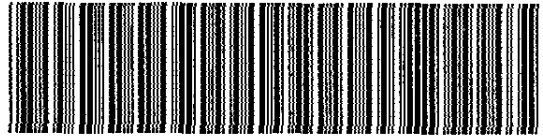

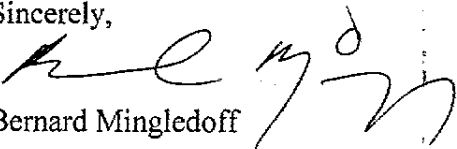

ARTICLES OF AMENDMENT 04 JAN -5 PM 2: 13

ARTICLES OF INCORPORATION SECRETARY OF STATE
OF TALLAHASSEE, FLORIDA

Abundant Harvest International Fellowship Ministries, Inc.

Pursuant to the provision of section 617.1006, Florida Statutes, the undersigned Florida non-profit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: The date of filing of the articles of incorporation was June 10, 2003.

SECOND: The corporation has adopted the following amendment(s) to the articles of organization:

Article III – Purposes is hereby amended to include the following:

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)3 of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law or (b) by a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Furthermore, upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and or/or scientific purposes and which has established its tax exempt status under section 501(c)3 of the Internal Revenue Code.

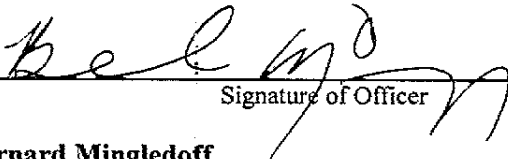

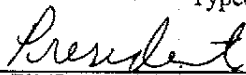

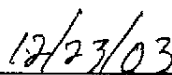
