ARTICLES OF INCORPORATION OF

LAKESIDE GARDENS II CONDOMINIUM ASSOCIATION, INC.

(A NON-PROFIT FLORIDA CORPORATION)

ARTICLE I.

The name of this corporation is LAKESIDE GARDENS II CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 24100 Tiseo Blvd, Unit 4, Port Charlotte, Florida 33980, and the initial mailing address of the corporation is 24100 Tiseo Blvd, Unit 4, Port Charlotte, Florida 33980.

ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed Lakeside Gardens II, a Condominium, located in Charlotte County, Florida, and to operate property owned by the Association.

ARTIÇLE III.

The terms used in these Articles of Incorporation shall have the same definitions and meanings as those set forth in the Declaration of Condominium of Lakeside Gardens II, a Condominium.

ARTICLE IV.

This corporation shall exist perpetually. In the event, however, this Association is dissolved, the control or right of access to the property or common elements of the Condominium containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility and that if not accepted, then the surface water management system facilities shall be conveyed to a not-for-profit corporation similar to the Association.
