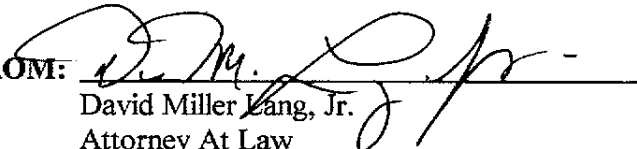

**ARTICLES OF INCORPORATION**  
**OF**  
**CHRISTIAN FELLOWSHIP COMMUNITY CHURCH, INC.**

The undersigned, as incorporator and on behalf of the existing association known as Christian Fellowship Community Church, desiring to form a corporation not for profit under Chapter 617, Florida Statutes, does agree that:

**ARTICLE I. CORPORATE NAME.**

The name of this Corporation is Christian Fellowship Community Church, Inc. .

**ARTICLE II. PRINCIPAL OFFICE.**

The initial principal place of business and location of the church shall be at North County Road 307A, Trenton, Florida, and the mailing address of this Corporation is P.O. 699, Trenton, Florida 32693.

**ARTICLE III. PURPOSES.**

The purposes for which this corporation is organized are: to teach the Holy Bible as the inspired word of God; to proclaim the gospel of Jesus Christ to every person; to spread the Christian faith and message; to maintain a worshiping fellowship; to minister to persons in the community and throughout the world; and to transact any and all lawful business permitted by corporations not for profit under the laws of Florida and the United States.

#### **ARTICLE IV. QUALIFICATION OF MEMBERS.**

All persons who are members of the Christian Fellowship Community Church, Inc. on the date these Articles are filed in the office of the Secretary of State shall be members of this corporation.

This is a sovereign and democratic church under the Lordship of Jesus Christ. The membership retains unto itself the exclusive right of self-government in all phases of the spiritual and temporal life of this church.

The membership reserves the exclusive right to determine who shall be members of this church and the conditions of such membership.

Any person may offer himself or herself as a candidate for membership in this church. All such candidates shall be presented to the church at any regular church service for membership in any of the following ways:

(1) By profession of faith according to the policies of this church.

(2) By promise of a letter of recommendation from another Church of like faith and order.

(3) By a statement of prior conversion experience in a Church of like faith and order when no letter is obtainable. Should there be any dissent as to any candidate, such dissent shall be referred to the membership for investigation and the making of a recommendation to the church within thirty (30) days. A three-fourths vote of those church members present and voting shall be required to elect such candidates to membership.

#### **ARTICLE V. INITIAL REGISTERED AGENT AND OFFICE.**

The street address of the Corporation's initial registered office is 621 NE 2nd Street, Trenton, Florida 32693 and the name of the Corporation's initial registered agent at that office is Cloud E. Haley.

The Board of Directors from time to time may move the Registered Office to any other address in the State of Florida.

#### **ARTICLE VI. INCORPORATOR.**

The name and street address of the incorporator of these Articles of Incorporation is Cloud E. Haley, 621 NE 2nd Street, P.O. Box 699, Trenton, Florida 32693.

#### **ARTICLE VII. THE NATURE OF BUSINESS AND POWERS.**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida by corporations not for profit, consistent with and in accordance with generally recognized operations of a church.

#### **ARTICLE VIII. TERM OF EXISTENCE.**

This Corporation shall have perpetual existence commencing upon the filing of these articles.

#### **ARTICLE IX. BOARD OF DIRECTORS.**

This Corporation shall have five directors initially. The number of directors may be increased or decreased from time to time by bylaws adopted by the directors, but shall never be less than three. Directors shall be elected or appointed in the manner and for the terms provided in the Articles Of Incorporation or the bylaws

#### **ARTICLE X. INITIAL DIRECTORS AND OFFICERS.**

The names of the initial directors of this Corporation and their addresses are: Stephen Long, 1005 NW 17th Ave., Chiefland, Florida 32626; Cloud E. Haley, P.O. Box 699, Trenton, Florida 32693; Christopher Ruggles, P.O. Box 996, Bell, Florida 32619; Helen Stoneking, 4651 NW 155th Street, Trenton, Florida 32693; and Judy Boyd, 5180 SW CR 341, Trenton, Florida 32693. The persons named as initial directors shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified, whichever occurs first. The

Directors as named herein shall also have the duties and responsibilities as set forth in the Articles Of Incorporation or the bylaws of Christian Fellowship Community Church, Inc.. Election of Directors in the future shall be governed by and stated in the bylaws.

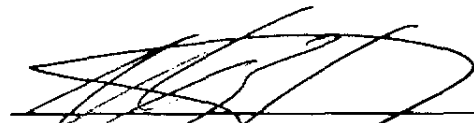
#### **ARTICLE XI. BYLAWS.**

The bylaws of the corporation are to be made, altered or rescinded by the members of the corporation and shall be in substantial form and general compliance with the bylaws of Christian Fellowship Community Church, Inc. as subsequently established following the date these Articles are filed in the office of the Secretary of State.

#### **ARTICLE XII. AMENDMENT.**

Amendments to these Articles may be proposed by any member at a regular business meeting called for that purpose, provided each amendment shall have been presented in writing at a previous business meeting and copies of the proposed amendment shall have been furnished to each member present at the earlier meeting. At least seven (7) days notice shall be given before the adoption of any amendments. Notice shall be given in the manner provided in the bylaws. Any amendment may be adopted by a majority of the members present at the meeting and voting.

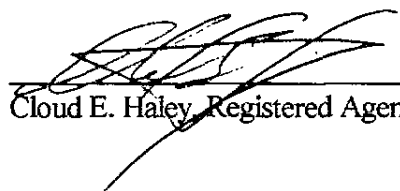
