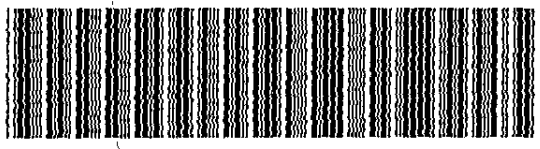

**ARTICLES OF INCORPORATION  
OF  
SAMARIA EVANGELICAL CHURCH OF LAKELAND, INC.**

We, the undersigned persons of the State of Florida, all of whom are of legal age, each being competent to contract, hereby from ourselves and our successors into a corporation not for profit under the Laws of the State of Florida, and hereby adopt the following Articles of Incorporation.

**ARTICLES I- NAME**

**The name of this corporation shall be: Samaria Evangelical Church of Lakeland, Inc.** with principal place of business located at 710 Massachussetts Ave., Florida, 33801. The name of this corporation initial registered agent and his address is:

**ARTICLES II- PURPOSE**

The general nature, object and purpose of this corporation is as follow:

- A. To establish and maintain a place for the worship of Almighty God, our Heavenly Father to provide for Christian fellowship for those of like precious faith, were the Holy Ghost may be honored according to our distinctive testimony, to assume our share of responsibility and privilege of propagating the gospel of Jesus Christ by all available means, both at home and abroad.
- B. To perpetuate, promulgate, and support the doctrines of the Samaria Evangelical Church of Lakeland, Inc., and it, and all its property, both real and personal, shall be subject to the laws, usages and ministerial appointments of the Mision Samaria Evangelical Church, Inc. 412 East 14 Street, Bronx, New York 10454. as are now or shall be from time to time established, made and declared by the lawfull authority of the said Mission.

**ARTICLES III- PROPERTY**

The corporation shall have the power to buy, acquire, and hold title in fee simple, in trust, or otherwise, to both real and personal property, and improve, encumber, sell, convey and dispose of all such property, to borrow money, execute notes, bonds, and other evidence of indebtedness and to secure the same by mortgage and deeds of trust, annuity bond, and other instruments of indebtedness and to pay interest thereon, to improve adapt. and use property held by it for: The said church corporation or the income therefrom in the religious, educational benevolent, or social activities of the said corporation or its successor without financial profit to its members except as may be necessary in the payment of salaries, or other comepensation for

services rendered and the corporation shall have the power to erect and maintain bulding to be to be utilized by the said church, for the worship of God. For the training in Christian Faith and to build and mantain residence for the use and occupancy of the minister of said church corporation. In conformity with the by -laws of said corporation and all the power a right granted to corporation not for profit under the laws of the State of Florida.

#### ARTICLES IV-MEMBERSHIP

The member of the corporation shall be all members in good standing at any given time of the said Church Corporation of Florida, provided, however, neither the incorporators nor the members of the corporation shall have any vested right , interest, or privilege of, in or to the assest functions, affairs or franchises of this corporation, or any right, interest of privilege which may be inheritable, or shall continue after his membership ceases in the aforementioned corporation. This corporation shall not have the power to by, mortgage, sell encumber or deed or dispose of any property which it may acquire, without the consent or the direction of a two-thirds (2/3) majority vote of the member, or its successors.

#### ARTICLES V-TERM

This corporation shall exist perpetually or until dissolved by due process of the law. Should this corporation ceases to exist as a legal entity and its charter be terminated, title to all its property automatically shall become vested in the Mission Samaria Evangelical Church, Inc., 412 East 144 Street, Bronk, New York 10454. In the same manner as it holds title to any other property.

#### ARTICLES VI- SUBSCRIBER

The name of the original incorporators and subscribers to these article are as follow:

#### ARTICLES VII- OFFICERS

The officers who are to manage the affairs of this corporation shall be as follow: President, a Secretary and a Treasurer, which three officers shall be the Trustees of the corporation, and such other officers as shall be provided for in the by laws, all of whom shall constitute and be the official Board of Directors.

They shall be elected from time to time in accordance with the bylaws and each shall hold office until his successor is elected and qualified, shall attest all legal contracts authorized by the members of this corporation and the laws of the State of Florida.

#### ARTICLES VIII- FIRST OFFICERS

The name of the officers who are to manage the affairs of this corporation, and the office which they will respectively hold until their successors are elected and qualified, and are as

Each of these member of the Board of Directors.

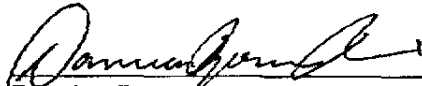
#### ARTICLE IX- BY-LAWS

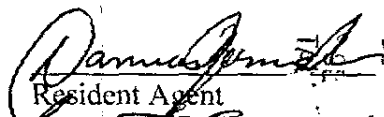

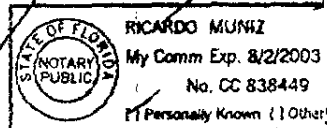
