ARTICLES OF I NCORPORATION OF

ALHAMBRA GARDENS CONDOMINIUM OF MIAMI, CORP, (A NON-PROFIT FLORIDA CORPORATION)

ARTICLE I

The name of the corporation shall be: ALHAMBRA GARDENS CONDOMINIUM OF MIAMI, CORP. The initial principal office of the corporation is 2401 SW 10TH STREET Miami Florida 33 B5, and the initial mailing address of the corporation is 2401 SW 10TH STREET Miami Florida 33 B5.

ARTICLE II

The purpose for which this corporation is organized is to act as the governing association of the proposed ALHAMBRA GARDENS CONDOMINIUM, located in Miami-Dade County, Florida, and to operate property owned by the Association.

ARTICLE III


