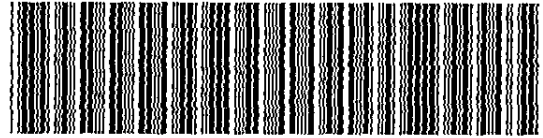

I, the undersigned, being of legal age and natural person, do hereby subscribe to, acknowledge and file the following articles of Incorporation for the purpose of creating a Not for Profit corporation in the State of Florida in Compliance with Chapter 617, F.S. (Florida Laws).

ARTICLE I

The name of this corporation shall be **Alyssa & Friends Learning Center, Inc.** and the initial address of the corporation shall be 8990 N.W. 62<sup>nd</sup> Street, Tamarac, Florida 33321.

ARTICLE II

This corporation may engage in the business of Child Care and the Educational development of children (Learning Center) under the law of the State of Florida.

ARTICLE III

At a meeting on July 10, 2003 of Alyssa & Friends Learning Center, an unincorporated group, it was decided by the qualified voters of this organization, that **Alyssa & Friends Learning Center, Inc.** would be the official name of the Learning Center.
