**ARTICLES OF INCORPORATION
OF
GREATER FORT MYERS SOCCER CLUB, INC.
(A Corporation Not For Profit)**

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Articles of Incorporation:

**ARTICLE I.
NAME**

The name of the Corporation is Greater Fort Myers Soccer Club, Inc.

**ARTICLE II.
DURATION AND COMMENCEMENT**

The term of the Corporation is fixed in perpetuity and will commence on the date that these Articles of Incorporation are filed with the Department of State.

**ARTICLE III.
NONSTOCK BASIS**

The Corporation is organized on a non-stock basis. The Corporation may not issue shares of stock.

**ARTICLE IV.
NOT FOR PROFIT**

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income, assets, or net earnings of the Corporation may be distributed to or for the benefit of its Members,

Trustees, or Officers, except to the extent that such payments are made permissible by these Articles of Incorporation.

ARTICLE V. PURPOSES

The Corporation is organized, and will be operated exclusively for the following purposes:

- A. For charitable, educational, and scientific purposes within the meaning of Section 170(c)(2), 501(c)(3) (pursuant to Section 501(k)), 2055(A)(2), and 2522(a)(2) of the Internal Revenue Code of 1986, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of said Code (or the corresponding provision of any future United States Internal Revenue Law).
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease, or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate, or otherwise dispose of such property and the income, principal, and proceeds of such property, for any of the purposes set forth herein.
- C. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- D. To provide and promote soccer activities to the Community.

ARTICLE VI. AUTHORIZED PAYMENTS

The corporation is hereby authorized and empowered to pay reasonable compensation for goods or services rendered by Members, Trustees, or Officers; and to make payments and distributions to anyone in furtherance of the purposes set forth in Article V (Purposes) hereof.

ARTICLE VII.
INITIAL BOARD OF TRUSTEES

The Board of Trustees will manage the business affairs of the Corporation. Initially, the Board of Trustees will consist of six members. The number of Trustees may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but may never be less than three. The Voting Members of the Corporation will elect the Trustees annually, at a time and manner prescribed by the Bylaws. 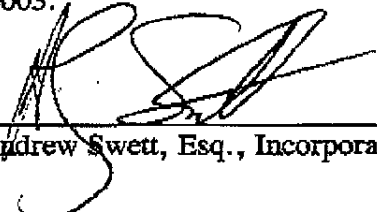

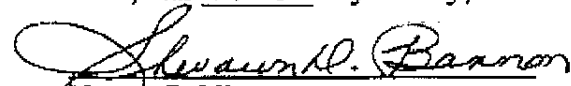

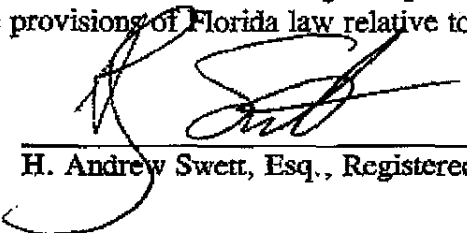
