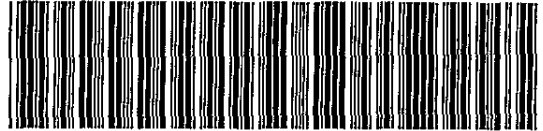

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation is CHURCH IN THE GLADES, INC.. The principle address of the corporation is: 1302 N. 30th Rd., Hollywood, FL 33021

ARTICLE TWO MAILING ADDRESS

The mailing address of this corporation shall be: 1302 N. 30th Rd., Hollywood, FL 33021.

ARTICLE THREE PURPOSE(S)

The purpose for which the corporation is organized is to form a Church. The purpose of the Church is to glorify God by Fulfilling the Great Commandment (Matthew 22:36-40) and the Great Commission (Matthew 28:18-20)

1. EVANGELISM/MISSION- "To share the good news of Jesus Christ with as many people as possible in our community and throughout the world" (Matthew 28:18-20, Acts 1:8, 2 Peter 3:9)
2. EDUCATION- To help members develop toward full Christian maturity and train them for effective ministry. To promote personal, spiritual growth and discipleship through Bible teaching" (Ephesians 4:11-13, Matthew 18:20, 1 Timothy 2:2)
3. WORSHIP- "To participate in public worship services together and to maintain personal daily devotions." (John 4:24)
4. MINISTRY/SERVICE- "To serve unselfishly, in Jesus name meeting the physical, emotional, and spiritual needs of those in our Church, community and in the world." (1 Peter 4:10-11, Matthew 25:34-40, 1 Thessalonians 5:11, Galatians 5:13)
5. FELLOWSHIP- "To encourage, support and pray for each other as members of the family of God. To share our lives together." (1 John 1:7, Acts 2:44-47, Hebrews 10:23-25, Romans 15:5,7, John 13:34-35)

It is not the purpose of this corporation to make profits, but rather to provide services in the name of Jesus.

ARTICLE FOUR MANNER OF ELECTION OF DIRECTORS

ARTICLE FIVE LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, with no limitations:


